#### 1. Introduction

The Information and Library Network (INFLIBNET) Centre is an autonomous Inter-University Centre (IUC) of the University Grants Commission (UGC) located at the Gujarat University Campus, Ahmedabad. Major activities and services of the Centre are geared towards modernization of academic libraries and information centres, to promote information transfer and access, to support scholarship, learning and academic pursuits. The Centre acts as a nodal agency for networking of libraries and information centres in universities, institutions of higher learning and R & D institutions in India. It was established as an independent autonomous Inter-University Centre (IUC) of UGC in May 1996 and set out to be a major player for promoting scholarly communication among academicians and researchers across the country.

#### 2. Vision and Mission

- To usher the country in the era of Information Technology allowing the academic and research community to derive its benefits. To create a wave of awareness through out the country about IT;
- To improve capability in information transfer and access, that provides support to scholarship, learning, research and academic pursuits;
- To carry out modernization of libraries and information Centres in the country, with application of computer and communication technologies; and
- To promote and steer a cooperative endeavor in resource development, sharing and its utilization at national level using the IT enabled services.

## 3. Aims and Objectives

The Objectives and functions, for which INFLIBNET Centre was established, as per its Memorandum of Association (MOA) are as follows:

- a) To promote and establish communication facilities to improve capability in information transfer and access, that provide support to scholarship, learning, research and academic pursuit through cooperation and involvement of agencies concerned;
- b) To establish INFORMATION AND LIBRARY NETWORK "INFLIBNET" a computer communication network for linking libraries and information Centres in universities, deemed to be universities, colleges, UGC information centres, institutions of national importance and R&D institutions, etc. avoiding duplication of efforts.
  - i. to promote and implement computerization of operations and services in the libraries and information centres of the country, following a uniform standard;
  - ii. to evolve standards and uniform guidelines in techniques, methods, procedures, computer hardware and software, services and promote their adoption in actual practice by all libraries, in order to facilitate pooling, sharing and exchange of information towards optimal use of resources and facilities:
  - iii. to evolve a national network interconnecting various libraries and information centres in the country and to improve capability in information handling and service;

- i. to provide reliable access to document collection of libraries by creating on-line union catalogue of serials, theses/ dissertations, books, monographs and non-book materials (manuscripts, audio-visuals, computer data, multimedia, etc.) in various libraries in India:
- ii. to provide access to bibliographic information sources with citations, abstracts, etc. through indigenously created databases of the Sectoral Information Centres of NISSAT, UGC Information Centres, City Networks and such others and by establishing gateways for on-line accessing of national and international databases held by national and international information networks and centres respectively;
- iii. to develop new methods and techniques for archival of valuable information available as manuscripts and information documents in difference Indian languages, in the form of digital images using high density storage media;
- iv. to optimize information resource utilization through shared cataloguing, inter-library loan service, catalogue production, collection development and thus avoiding duplication in acquisition to the extent possible;
- v. to enable the users dispersed all over the country, irrespective of location and distance, to have access to information regarding serials, theses/dissertation, books, monographic and non-book materials by locating the sources wherefrom available and to obtain it through the facilities of INFLIBNET and union catalogue of documents;
- vi. to create databases of projects, institutions, specialists, etc. for providing on-line information service:
- vii. to encourage co-operation among libraries, documentation centres and information centres in the country, so that the resources can be poled for the benefit of helping the weaker resource centres by stronger ones; and
- viii. to train and develop human resources in the field of computerized library operations and networking to establish, manage and sustain INFLIBNET.
- c) To facilitate academic communication amongst scientist, engineers, social scientists, academics, faculties, researchers and students through electronic mail, file transfer, computer/audio/video conferencing, etc;
- d) To undertake system design and studies in the field of communications, computer networking, information handling and data management;
- e) To establish appropriate control and monitoring system for the communication network and organize maintenance;
- f) To collaborate with institutions, libraries, information centres and other organizations in India and abroad in the field relevant to the objectives of the Centre;
- g) To promote R&D and develop necessary facilities and create technical positions for realizing the objectives of the Centre;
- h) To generate revenue by providing consultancies and information services; and
- I) To do all other such things as may be necessary, incidental or conducive to the attainment of all or any of the above objectives.

#### 4. Governance

The Apex body of Governance of INFLIBNET Centre is its Council which takes decision with regard to the policy matters and larger issues concerning to the development of the Centre. The INFLIBNET's Council is headed by the Chairman, University Grants Commission (UGC) as Ex-officio President of the Council. Financial decisions are taken by the Finance Committee. The executive decision making body is Governing Board and Chairman of the Governing Board is nominated by the President of the Council and Director of the INFLIBNET Centre is the Member Secretary of the Governing Board.

## 5. Major Activities, Functions and Services

Major activities, functions and services of the INFLIBNET Centre are as follows:

#### 5.1. Union Databases

The development of union databases of various library resources i.e. books, journals and theses has been one of the most important activities of the Centre since its inception. In the beginning, Centre funded potential universities of the country for creating bibliographic records of their library collections, the union databases available at the Centre is an outcome of the financial and logistic support offered to the universities by the Centre. Eight databases have been developed and are continuously growing. These databases are as follows:

**Books** 

Theses

Serial holdings

**Current serials** 

Secondary serials/CD-ROMs

DDC serials

**Experts** 

Research projects

The INFLIBNET Centre has been developing union catalogue of academic libraries in India Since the university libraries were given financial grants for library automation. Gradually, member libraries started contributing the data to INFLIBNET and it resulted in the enormous growth of union catalogue in past few years. The union catalogues contain bibliographic records of different type of materials viz. Books, Serials and Theses. This is the comprehensive and major source of bibliographic descriptions in academic and research arenas, and for collection development in libraries. For the Books Database, currently the centre has received 60 lakhs (aprox.) bibliographic records, contributed by 96 university libraries in India. Records are being processed for merging in to union database, which involves standardization, field and sub-field mapping and de-duplication. After processing of 52 university's records it contains 20 lakhs of unique records and the remaining records are under process. It provides bibliographic information contributed by the universities about each book with the library name. Books Database covers monographs, reference books, conference proceedings and textbooks. The participating libraries are regularly contributing records for merging their local holdings in to the union databases of INFLIBNET where a number of records are continuously growing.

## 5.1.1. New Search Interface for Access to Union Catalogue

Recently, INFLIBNET has developed a new interface for searching various databases, which is more efficient, user friendly and reliable. Entire records have been mounted on a new server. After series of testing, now it has been made available to the public for access. The URL is http://caliber2004.inflibnet.ac.in:7001/union.jsp. New and enhanced tool for searching the databases has many new features. Some of them are listed below:

- Efficiency in the search term with user-friendly help-messages
- · Provision for advanced search
- Navigation of records with various display format
- Feedback form for tracking the errors in the records
- · Integrated search for all the serials database
- All the databases are on one server.
- It revals the statistics of the records of each library
- Restriction of search limits
- Generating the ILL request form through the web

Entire search interface has been developed using JAVA as the basic programmeming language and MS SQL as the database server. For the development of web-based access to the databases, following software and hardware were used.




Figure-1: New Search Interface for accessing INFLIBNET Union Databases

## 5.2. UGC-Infonet Connectivity Programme

The UGC-Infonet Connectivity is one of the ambitious programmes of the UGC for building high-speed nation-wide communication network for Indian universities. The Honorable Sh. Atal Bihari Bajpai, the then Prime Minister formally inaugurated the UGC-Infonet on 28<sup>th</sup> December 2002 at New Delhi. As per the programme, the UGC-Infonet will boost the higher education system of the Country in following various ways:

- To become a vehicle for distance learning;
- Open access tool for education material and journals to remotest of areas;
- Pool of resources for researchers and scholars for tapping most up-to-date information;
- Medium for collaboration among teachers and students, not only within the country but also across the world;
- Intranet for university automation; and
- To establish a channel for globalization of education.

#### 5.3. UGC-Infonet E-Journals Consortium

The University Grants Commission (UGC) has initiated a programme to provide electronic access over the Internet to scholarly literature in all areas of learning to the university sector in India. The programme is wholly funded by the UGC. All universities which come under UGC's purview will be members of the programme, and it will gradually be extended to colleges as well. The programme is being executed by INFLIBNET Centre, Ahmedabad. Access to various E-Journals formally began on January 1, 2004. Trials were provided from October, 2003.

This programme will increase in a very fundamental way the resources available to the universities for research and teaching. It provides the best current and archival periodical literature, from all over the world, to the university community. The programme will go a long way in mitigating the severe shortage of periodicals faced by university libraries for many years, due to the ever-widening gap between the growing demand for literature, and the limits of available resources.

The E-Journals programme is a cornerstone of the UGC-Infonet effort, which aims at addressing the teaching, learning, research, connectivity and governance requirements of the Universities. The effort was announced by the Hon'ble Prime Minister of India, Shri Atal Bihari Vajpayee and the network was activated by the Hon'ble Minister for Human Resources Development, Dr. Murli Manohar Joshi, at the inauguration of the Golden Jubilee Celebrations of the UGC on December 28, 2002 at New Delhi. The E-Journals programme demonstrates how communication networks and computers can be used to stretch and leverage available funds in furthering these aims. The programme has been made possible due to the close understanding and cooperation between the UGC, ERNET, IUCAA and INFLIBNET and national and international publishers.

#### 5.3.1. The Consortium

The Consortium will ultimately cover all the universities in India which come under the purview of the UGC, and will gradually be extended to the colleges as well. The first phase of the programme covers more than 50 universities and additional universities will join the programme as soon as they have access to the Internet, which is separately being provided by the UGC under the UGC-Infonet Connectivity Programme. It is expected that the entire university system will be covered by June, 2004. Universities will become members of the Consortium after signing an MOU with the UGC and the INFLIBNET. The UGC provides funds for the programme, which is offered free-of-cost for the universities, during 10<sup>th</sup> plan period.

#### **5.3.2. History**

A Committee was setup by Prof Arun Nigavekar, Chairman, UGC to study the possibility of setting up of a consortium of universities, to obtain access to electronic versions of scholarly journals over the Internet, in all areas of learning of interest to universities. The Consortium envisaged providing access to journals covering current research, reviews and literature databases and gateway portals for users to easily access and navigate through the vast amount of literature. The committee had detailed discussions with university faculty, library science professionals, publishers and other experts, and considered data gathered by the INFLIBNET from various sources. The committee then made recommendations to the Chairman, UGC as to how the programme could be structured and executed. The Chairman, UGC then set up an expert committee to identify specific publications, interact on terms and conditions with publishers, and to make its final recommendations. It was also decided that INFLIBNET would be the nodal agency to execute the programme and to administer and monitor it as per the guidelines set by the expert committee from time to time. Following the recommendations of the expert committee, the Chairman, UGC has authorized INFLIBNET to enter into agreements with various publishers and to begin subscriptions to e-resources for universities.

## 5.3.3. Coverage

The E-Journals programme aims at covering all fields of learning of relevance to various universities including:

Arts, Humanities and Social Sciences

Physical and Chemical Sciences

Life Sciences

Computer Science, Mathematics, Statistics

The literature made available will include journals covering research articles, reviews and abstracting databases. Access will be provided to current and archival literature. Subject portals and navigation guides will be be be will be be be available users to navigate easily through all the literature that is made available.

## 5.3.4. Operation

The INFLIBNET is to administer and monitor the programme and will have independent electronic access to all the publications to help with the process. The Centre will get one free print copy of each journal, subscribed under the consortium, by some of the publishers for archival purpose. A web site http://web.inflibnet.ac.in/econsortia/index.htm is created to provide all required information to Consortium members about the status of the programme. INFLIBNET also carries out training programmes in various places to spread awareness and to develop expertise in the university community in the use of e-resources. Special training programmes are conducted on different University campuses by publishers of complex databases viz. Chemical Abstracts, Biological Abstract, etc

#### 5.3.5. Current Status

As of March 31, 2004 agreements have been reached with the following publishers for e-resources subscribed under the UGC-Infonet E-Journal Consortium. The number of journals accessible from each publisher is given in circular brackets:

#### 5.3.6. Future Plans

Resources will be made available to the universities through a continuous process which will bring in literature covering an ever increasing number of fields from a wide range of publishers all over the world. Programmes will be initiated to digitize and make electronically accessible literature which is present only in the print form, often unpublished, in various institutes and universities in India. Appropriate packages of the literature will be developed for use by students and teachers in various colleges. The community of teachers, library professionals and students from the university system will be consulted on a continuing basis in the development of the programme so that it remains up to date and useful.

#### 5.4. Software R & D and SOUL Software

#### 5.4.1. Updated Version of SOUL Software

The SOUL software released in the year 2000 during the CAILIBER at Chennai has become very popular during the short span of 3 years. It has been supplied to more than 350 universities/institutions across the country. The SOUL software package has come out with latest version incorporating features like; search engines, bar-coding technology, etc. The initial bugs in the software and the suggestions, modifications received from institutions time-to-time have been incorporated in the new version of SOUL. After rigorous testing, copies of the new version were sent to more than 125 user libraries free-of-cost, who had purchased the software. The INFLIBNET is now flooded with demands and requests from many more universities, colleges, government and other institutions for the supply of the software. Indira Gandhi National Open University (IGNOU) has identified the SOUL software for all its co-ordinating centres to teach in the courses of Library and Information Science.

## 5.4.2. Supply and Installations of SOUL Software

The Centre received a total number of 90 orders for supply and installation of the SOUL software. Besides that the INFLIBNET has made an agreement with Office of the Commissioner, Higher Education, Madhya Pradesh for Library Automation in Government Colleges of the state by using SOUL Software. In the first phase, the Centre has received 90 orders for supply and installation of SOUL Software. As per the agreement, the INFLIBNET Centre conducted training programmes on SOUL installation and usage in the state of Madhya Pradesh.

#### 5.4.3. SOUL Service Centres

Keeping in a view of the growing demand of SOUL software, a proposal was mooted through INFLIBNET-Governing Board and clearance received from UGC for setting-up of regional co-ordinators and service centres at Mumbai, Kurukshetra, Delhi, Hyderabad, Bangalore and Ahmedabad. Other regions are picking up and coverage will also be expanded into different states in near future.

## 5.5. R & D Projects

# 5.5.1. Health InterNetwork project of World Health Organization: Creation of experts database for medical professionals and organizations in India

The INFLIBNET has embarked upon the creation of experts database for medical professionals and organizations in India in collaboration with the World Health Organisation. The database is being developed under Health InterNetwork project of WHO. The Health InterNetwork (http://www.healthinternetwork.org) is a millennium initiative of the United Nations to respond to the challenges posed by the digital divide in the health sector.

Database covers the brief resume of professionals (Doctors, Professors, Researchers and other academicians) working in the field of medical science. Under this project, INFLIBNET has compiled 4000 profiles and they are hosted on the web site of National Health Information Collaboration (NHIC) http://203.197.175.21/nhic/index.asp. The same information is also available on our web site at http://nissat.inflibnet.ac.in. Apart from experts database, INFLIBNET has compiled online directory of medical institutions. This directory contains the information about the Name and contact addresses of the heads of institution, which can be searched under all important fields. The directory has been hosted on the web site of National Health Information Collaboration (NHIC) http://203.197.175.21/nhic/index.asp.

# 5.5.2. NISSAT (DSIR) Project: Developing and Managing a Web Enabled Database of Experts Manpower in Science and Technology

Experts database in Science and Technology (EDST) is a collective effort of INFLIBNET and NISSAT. It is NISSAT (DSIR) funded project for two years duration, which has been successfully completed. The project has been launched under the title "Developing and Managing a Web Enabled Database of Experts Manpower in Science and Technology". Under the project, INFLIBNET has collected the profiles of Scientists, other senior faculties working in leading R and D labs, universities, science and technology departments of central and state governments in the country. It provides comprehensive information about the background, skills, and accomplishments of the individuals. It provides access to relevant, accurate information that is supplied by the faculties themselves, verified and presented in a common format. The Web interface to the database enables the faculties to search, edit, browse and save the profiles from remote clients. It is most comprehensive database of its kind in the county and continues to expand further. It comprises detailed professional information for nearly 24,000 scientists, academicians and scholars across the country. #### 6. National and International Conventions

## 6.1. PLANNER-2003, November 6-7, 2003, NEHU, Shillong

First Convention entitled PLANNER – 2003 (Promotion of Library Automation and Networking in North Eastern Region) was organized by INFLIBNET in collaboration with North Eastern Hill University, Shillong during November 6-7, 2003 at North Eastern Hill University (NEHU), New Campus, Shillong. 330 delegates including 10 delegates from Bangladesh attended the convention. Majority of the participants were from the academic institutions/universities of North East India. This historical event was initiated by INFLIBNET to boost the automation and networking of libraries in North East Region. However there were representatives from other states too.

Mr. R G Lyngdoh, the Hon'ble Minister for Home in Meghalaya, inaugurated the convention and he expressed his happiness on organizing such a convention on most important topic relating to adoption of new technologies in libraries. He appreciated the efforts and initiatives taken by the Dr T A V Murthy, Director, INFLIBNET who rightly and timely thought of bringing first convention of PLANNER-2003 to Meghalaya. He also released Souvenir and Hindi version of SOUL (Library Management Software) manual on the occasion. Prof Mrinal Miri, the Vice-Chancellor of NEHU presided over the inaugural function. Earlier, Dr T A V Murthy while introducing the theme of the convention appreciated the co-operation extended by the professionals of North Eastern states who showed their concern and enthusiasm to hold this convention at this beautiful NEHU Campus. Mrs. I Majaw, Librarian, NEHU and the Organizing Secretary of the convention and Mr. Prem Chand, Scientist- C of INFLIBNET delivered welcome address and vote of thanks respectively. The theme of the convention was 'Automation of Libraries in North Eastern Region: Trends, Issues and Challenges'. There was overwhelming response to call for papers. Authors from different states contributed and presented papers during the convention. The proceedings containing 45 full-text papers presented in the form of well organized

and edited volume, was brought out as pre-convention publication of 384 pages, which included 24 authors from different parts of North East. Two tutorials on different topics were also arranged to familiarize the delegates with the processes and technical know-how of network and digitization techniques. About 120 delegates registered for tutorials on "Building Digital Libraries" and "How to set up LAN in Libraries". Dr. Veena Saraf, Reader, Department of Library & Information Science, NEHU and Sh. S K Sharma, Scientist-B, INFLIBNET Centre were the resource persons for these tutorials.

Technical sessions were held on November 6-7, 2003. Main theme of the Convention was categorized under two sub themes viz., IT based activities and Emergence of consortia. Commercial vendors were also given slots for presentation. Ch. Radheshyam Singh, Librarian, Manipur University chaired the first technical session, in which most of the papers discussed the automation status of different types of academic libraries mainly of North East India, highlighting the progress made during the last 10-15 years in the field of automation. The papers revealed that there are common problems such as lack of infrastructure, manpower, finances, etc. being faced by all the libraries and passive attitude of professionals and administrators towards IT application. Second area of discussion and presentation was use of library software, which varied from library to library with different standards and formats. There is hardly any uniformity and consistency in using tools and techniques of information processing and management. Such variations are creating bottlenecks in information sharing and exchange. However, some of the papers could suggest some guidelines for network planning including standardization

Second technical session was chaired by ProfAS Chandel, in which most of the papers were based upon case studies of different libraries covering networking, Online Public Access Catalogue, Web-based union catalogue being developed by INFLIBNET, need for information literacy, etc. While summing up the two technical sessions, it was quite explicit that proper strategic planning is required to promote and encourage IT application in libraries to take full advantages of new application in IT. The papers presented and discussed have given sufficient background for proper planning and implementation of IT based programmes.

Third technical session was chaired by Prof. Alka Bourgohain, which was devoted to consortia initiatives. Various models were discussed, some of which covered North Eastern Region too. There were presentations on existing consortia like INDEST, HELINET, FORSA, UGC-Infonet etc. including E-journals subscription. There were presentations by commercial organizations dealing with subscription of E-journals, discussing their services relating to full-text access to electronic journals.

Fourth technical session was chaired by Dr M Abdussar, Registrar, Royal University of Dhaka. The topics covered in various papers presented in the session were on search engines, digital library and Internet searching. Search features of various search engines were discussed with special emphasis on automatic indexing being done for Internet resources. Need for intelligent indexing was also referred for effective retrieval of information on Internet.

The convention concluded with valedictory function in which the proceedings of the convention were summarized by Prof A S Chandel, Head of DLIS at NEHU, Shillong who acted as Rapporteur General for the convention. The Chief Guest of the valedictory function was Mr. G P Wahlang, IAS, Commissioner of Education, Govt. of Meghalaya who, in his address, appreciated NEHU and INFLIBNET for bringing information professionals of North Eastern Region together to discuss their common problems relating to information organization and sharing. Registrar of NEHU, Prof. D T Khathing, Chaired the session. Dr. Veena Saraf and Mrs. I Majaw delivered the welcome address and vote of thanks respectively. During the

concluding session, delegates from Bangladesh and North East expressed their opinion about PLANNER and thanked the INFLIBNET for organizing this event at Shillong.

#### Some of the recommendations emerged out of the deliberations are as follows:

- There is a need to formulate guidelines, norms and standards for automation, networking, and information processing which all the academic libraries of the region should adopt.
- There is a need to formulate guidelines, norms and standards for automation, networking, and information processing which all the academic libraries of the region should adopt.
- INFLIBNET, in association with professional group of North East, may workout these standards and suggest the adoption of suitable hardware and software for the purpose.
- Academic libraries of the region should plan their own Library Network for mutual benefits as per requirements and needs of the region in addition of sharing other networks and consortia.
- Digitization lab should be established by pooling resources from UGC and other funding agencies in the region to initiate digitization process on sharing basis.
- As per suggestions from the participants of Bangladesh, the possibilities of information sharing may be explored between the two countries by INFLIBNET.
- Establishment of sub-centre of INFLIBNET in North Eastern region was also suggested, preferably in NEHU Campus, which has maximum infrastructure facilities for the purpose.

Shri Prem Chand and Shri K Prakash of INFLIBNET Centre, acted as Chief Coordinator and Convener respectively from the Centre for coordinating this activity.

#### 6.2. International CALIBER-2004, February 11-13, 2004, Jamia Milia Islamia, New Delhi

INFLIBNET's annual International CALIBER – 2004 was held at Jamia Millia Islamia, a Central University at New Delhi during 11-13 February, 2004 on the theme "Road Map to New Generation of Libraries Using Emerging Technologies". Inaugural session started with welcome address by Shri Syed Shahid Mahidi, the Vice Chancellor of Jamia Milia Islamia and introductory remarks by Dr. T.A.V. Murthy, the Director of INFLIBNET Centre. Prof. Yash Pal, National Research Professor and Ex-Chairman of UGC delivered his address and pointed out that the architecture of information is more important than what is available on the web. He suggested the librarians and academicians to work for a global information environment where all can share and exchange their information with each other. Prof. Arun Nigavekar, Chairman, UGC and the Chief Guest, in his inaugural address revealed UGC's objective of bringing technology to classrooms. He told that the success of UGC Infonet (UGC's new initiative to network Indian Universities) and E-journals initiative would be visible only if the changes are happening at grass root level of education and research. Automatic change in the mindsets of academicians is the need of the hour. He urged the INFLIBNET to conduct orientation and awareness programmes on IT and Internet use, across the country and educate academicians and students. He also released the conference proceedings and Prof. S.G. Mahajan felicitation volume. Dr. T.A.V. Murthy felicitated Prof. Mahajan. While speaking on the occasion Prof. Mahajan congratulated UGC-INFLIBNET for taking new initiative for the benefit of research and academic community. He also released SOUL manuals in regional languages viz., Telugu,

Malayalam, Punjabi and Oriya. Dr. Gayas Makhdumi, Organising Secretary and University Librarian, Jamia Millia Islamia proposed vote of thanks. The programme was well attended by more than 240 national and international delegates, invitees, guests and press-media.

The proceedings of CALIBER-2004 started with technical session on the sub-theme "Digital/Virtual/E-Libraries". Dr. (Mrs.) M D Baby, Member of INFLIBNET Council and University Librarian, Cochin University of Science & Technology was the chairperson of the session assisted by two rapporteurs. There were 32 papers accepted for presentation and out of that, 18 papers were presented. Dr. S. Venkadesan, Librarian, Indian Institute of Science, Bangalore, presented the invited theme paper on 'Strategic Planning and Policy for Collection Development of E-resources to Satisfy User Requirements: A Case study of JRD Tata Memorial Library'. He gave a concise as well as comprehensive picture of E-Collection development by extracting the best practices emerging from the Tata Library experience. All the other papers in the first session addressed the significant issues such as digital information, digitization processes, case studies of digital libraries, digital conversion of special collection such as photographs, personalization system, interconnectivity, interoperability, digitization of cultural heritage, communication in digital libraries, standards and protocols and institutional repositories for holding and storing digital information and archival practices. Apart from training of staff of the library to digital world, user orientation to the digital information and ethical and fair use of digital resources were discussed. A very pragmatic issue raised and discussed in the first session was the print vs. electronic resources. This discussion led to another pertinent issue, 'interface between print and electronic'. After the presentation of papers, interesting and significant issues were raised by participants that took the session in the right direction. The feedback of the participants has helped to identify the main tasks left before the digital librarians.

On the Day 2, the theme "Strategic Planning and Catalyst for New Generation of Libraries" was taken for presentation and discussion. This session was chaired by Dr (Mrs) N J Deshpande from Department of Library and Information Science of Pune University who was assisted by the Rapporteurs Mr.Basur Ahmed and Dr Uma Kanjilal. In this session, there were 24 papers, out of which 17 were presented. In the theme paper, "Strategic Planning and Catalysts for New Generation of Libraries", Dr. Rama Reddy, University Librarian of Hyderabad University specified the relevance of strategic planning and management in the modern libraries and information centres. He also codified the impact of changes in the planning environment and suggested the action plan for effective strategic planning for new generation of libraries. The issues and technologies addressed by others in this session were: challenges in the academic library, strategic planning for new technology in libraries, technological and legal implications of digital libraries, Intellectual Property Rights in the changing scenario, IT applications and implications of IT, digital information users, architecture and retrospective conversion. The content of the papers were based on observations, case studies and experimentation. During the session, a renowned library professional, Dr. Jaginder Singh Ramdev, who is the founder of SATKAL Trust, addressed the delegates. Dr. TAV Murthy, Director of INFLIBNET, felicitated him with a memento. Dr. P. Padhi from Utkal University chaired technical session on "Web Content Management" assisted by Dr Amritpal Kaur and Dr Sreenivaslu. Altogether there were 18 papers to be presented in the afternoon session; only 7 papers were presented including one theme paper. Dr. Hildrun Kretschmer initiated the theme paper on Webometrics with comparison with bibliometrics, scientometrics, and webometrics. There were two papers on data mining, two papers on knowledge management, one paper each on MyLibrary, XML for information portals and Knowledge Discovery in Databases.

Lot of interests was generated on the paper MyLibrary and the presenter answered a number of questions put by the participants. Sessions of the second day came to an end with a presentation on E-

Subscription consortia under UGC-Infonet, made by Dr. V S Cholin of INFLIBNET, which was supplemented by clarifications from Dr. TAV Murthy, Director of INFLIBNET. Dr. Murthy also embarked upon new initiatives of INFLIBNET and requested the whole-hearted support from librarians and academic fraternity.

Dr E Rama Reddy, University Librarian of Hyderabad University chaired the last session on "Emerging Technologies" and Shri Rajesh Chandrakar and Shri S Naqvi assisted him as Rapporteurs. It started with theme paper on "Emerging Technologies" presented by Shri S M Salgar, Scientist-G of INFLIBNET Centre. He covered all sub-theme areas and presented the latest and emerging technologies, which will change today's functions of libraries. He described the topics like networking, wireless LANs, digital services, e-education, distributed databases, mirror sites, etc. and tried to relate them with Library services. Out of 18 papers accepted for presentation, authors presented 10 papers. 6 papers covered W-LAN application in libraries; one each was on application of smart card technology, Info ATM, e-learning and digital repositories. All the papers described the ideas of library professionals in India, to acquire and implement the emerging technologies in their libraries to serve the user community.

Concluding ceremony started with the brief introduction by Shri S M Salgar about the conference and welcome address by Dr T A V Murthy. The Rapporteur General of the convention Dr B Satyanarayana, University Librarian of J N Technical University, Hyderabad presented the report of technical sessions. Few International delegates spoke on their experiences about CALIBER, like Dr Muhammed Ramzan (Pakistan), Dr Hildrun Kreshtmer (Germany), Dr H Suhaimi Abdul Karim (Brunei) along with Dr E Rama Reddy from University of Hyderabad. INFLIBNET Council Member Dr (Mrs) M D Baby from Cochin University of Science and Technology and GB Member Dr (Mrs) Nupur Prakash from GGS Indraprastha University, New Delhi also spoke on the occasion. The Chief Guest Prof J L Sardana, a distinguished Librarian and ex-President of ILA applauded INFLIBNET and JMI team for the wonderful convention organized. He also praised the progress made by the INFLIBNET and urged UGC for appointing more scientific staff for the smooth functioning of the programme. He also demanded for a national level coordination centre to look after the digital library initiatives in the country and according to him INFLIBNET will be the appropriate body to do the job. Prof Sardana released "Librarians' Guide to WWW" a book jointly written by Shri Suresh Panwar, Scientist-B, INFLIBNET and Dr T A V Murthy. Director, INFLIBNET distributed mementos to invited guests and foreign delegates. The concluding session came to an end with vote of thanks proposed by Dr Gayas Makhdumi, the Organising Secretary of International CALIBER-2004.

Shri S M Salgar from INFLIBNET acted as the Coordinator and Dr P Pichappan, LIS Professor from Annamalai University and President of Digital Information Research Foundation acted as the Co-ordinator for the technical sessions, respectively. The proceedings of the convention, containing 78 technical papers was brought out in book form. A daily newsletter "CALIBER-2004 Update" was published in the conference venue everyday covering programmes, news, interviews and photographs. Around 240 professionals from India and few from abroad attended the Convention. Around 25 librarians sponsored by Indian Council for Agricultural Research under World Bank NATP attended the conference. They felt that CALIBER-2004 was an excellent opportunity to interact with experts in the field and it will boost the ongoing initiatives for uplifting LIS system in agriculture libraries.

A good number of LIS students including a group of students from Saurashtra University also participated in the convention. Thomson-ISI and Elsevier Publishers arranged two commercial presentations and good number of companies participated in the exhibition held at the convention venue. Organizing committee also arranged cultural programmes for the delegates and invitees. Through this convention, INFLIBNET proved that it is not just creating a network of libraries but also mobilizing the concept of human resources development to transfer the concepts, knowledge and technology across the wide spectrum of library and information community.

Shri Yatrik Patel and Shri J K Vijayakumar acted as Convener and Co-Convener for the organizing committee and coordinated the CALIBER related activities from the Centre.

Twenty-five librarians participated in the programme.

## 7.1.8. IRTPLA, Burdwan, West Bengal, 17th to 21st December 2003

IRTPLA for West Bengal State was organized at Burdwan University, Burdwan during 17-21 December 2003. Prof L K Samanta, the Dean of Science faculty inaugurated the programme and Prof S P Biswas, Head of Department of Library and Information Science presided over the function. ## 7.2. E-resources Management Training Programmes & Workshops

The training programmes and workshops were conducted for the library and computer science professionals on usage and management of e-resources subscribed under UGC-Infonet consortium. The details of the training programmes are given below.

The first training programme on "E-resources management in Networked Environment" held at INFLIBNET Centre on May 26-30, 2003. The programme was inaugurated by Dr. TAV Murthy, Director, INFLIBNET Centre. 20 participants from different parts of the country attended the programme.

The second Training Programme on E-Resource Management for 14 professionals, who are looking after UGC-Infonet in member universities from Library side, was held at INFLIBNET Centre on December 1-5, 2003. Sh. S.M. Salgar, Scientist-G, INFLIBNET Centre, inaugurated the Programme.

The third Training programme was held at INFLIBNET Centre on January 5-9, 2004. The Programme was inaugurated by Dr. TAV Murthy, Director, INFLIBNET and 19 participants attended the Programme.

The fourth Training Programme was held at INFLIBNET Centre on February 3-7, 2004. Nineteen participants took the training regarding the management of electronic resources. Dr. T A V Murthy, Director, INFLIBNET Centre inaugurated the programme.

All publishers and their representatives made presentations on various resources in addition to the faculty drawn from the INFLIBNET Centre. Dr V S Cholin, Scientist-B, INFLIBNET acted as the Course Coordinator for these programmes.

#### 7.3. One-Day User Awareness Programmes

#### 7.3.1 Training Programme at the Gujarat University, Ahmedabad, June 10, 2003

The first One-day Orientation Training Programme for faculty and research scholars was arranged at the Centre on 10<sup>th</sup> June 2003. Twenty one participants from Gujarat University and Gujarat Vidyapith participated in the programme. Inaugurating the programme, Sh. S M Salgar, Senior Scientist of the Centre informed the participants that the series of orientation programmes are planned by the Director, INFLIBNET across the country and urged the participants to be ambassadors of INFLIBNET and work as spokespersons of INFLIBNET to spread the message of UGC-Infonet and its benefits. Dr. V S Cholin, Scientist-B coordinated the programme.

The programme had few sessions on INFLIBNET and its activities, UGC-Infonet and e-subscription to scholarly journals and databases. The participants worked extensively on the use of gateway portals, databases and full-text access to journals and were impressed upon the facilities being offered by UGC under its Infonet programme through INFLIBNET Centre. It was announced that the INFLIBNET will organize series of user awareness programmes at different universities for the benefit of research and academic community.

#### 7.3.2. Gujarat University, Ahmedabad, December 31, 2003

The second one-day Orientation Programme on E-Resources under UGC Infonet for faculty and research scholars of Gujarat University was arranged at the INFLIBNET Centre on 31<sup>st</sup> December 2003. 24 participants from Gujarat University, Ahmedabad attended the training programme. Shri S M Salgar, Scientist-G inaugurated the programme and informed that this kind of programmes will be held across the country. Detailed lectures were held about UGC-Infonet, E-resources subscription initiatives by UGC and hands on practical cum demonstrations were also arranged for accessing various databases and gateway portals. Dr. TAV Murthy, Director, INFLIBNET Centre distributed certificates to the participants, on the concluding session. Dr. V S Cholin, Scientist-B coordinated the programme.

#### 7.3.3. National-Level Training Programme

Awareness is very important for success of e-subscription initiative. During the inauguration of International CALIBER 2004, Chairman, UGC urged the INFLIBNET Centre to organize "User Awareness Programme" across the country to nurture the culture of using e-resources by faculty and research scholars. He told that the users need to get exposed to the resources subscribed under this programme. By taking into account these facts, one-day user awareness programmes are planned at individual universities, where INFLIBNET depute a team to execute these programmes and university coordinate it. It is expected that individual universities will conduct such programmes regularly to inform the users about the new developments, etc.

## 7.5. IT@AGRILIBNET-2003

With the support received from the World Bank through National Agriculture Technology Project (NATP), Indian Council for Agricultural Research with its great vision embarked upon training the manpower in libraries as a pre-requisite to implement its total library automation and networking programme in Agriculture sector across India. By taking into account INFLIBNET's highly recognized training capabilities, NATP authorities selected it as the national level training centre for Agriculture Librarians in India. Dr TAV Murthy, Director of INFLIBNET Centre, accepted the Herculean and motivating task given, after obtaining necessary permission from the University Grants Commission.

The INFLIBNET has successfully conducted nine training programmes during June – September 2003, under the title "ICAR-INFLIBNET Training Programme for Agriculture Librarians on Networking and E-Resources Management [IT@AGRILIBNET-2003]" as a series with two weeks duration each, specially designed for Agriculture Library professionals from institutes and universities. The course contents were identified in consultation with senior agriculture librarians and the INFLIBNET technical staff. The topics were selected keeping in view the objectives of this programme, i.e., awareness building of the most modern technologies and nurturing IT culture in agriculture librarians. The following broad topics were selected in which specialized INFLIBNET faculty delivered comprehensive lectures as mentioned below and practical aspects with equal emphasis:

Basics of Computer and Hardware/Software;

Planning for LAN in Libraries;

Network Security Issues;

Mail Server and Web Server Configurations & Applications;

Library Management Software Systems and SOUL;

Website Designing and Hosting;

Creation of Digital Libraries using Greenstone Digital Library Software;

Impact of INTERNET and Identification of Resources;

INTERNET Resources and Gateways for Agriculture Scientists; and

Design of a Model Agriculture Information System.

In addition to these, invited external faculties handled topics related to experiences in library automation, digital library creation and networking. Study tours to different libraries to understand the proper deployment and implementation of modern technologies were also arranged for the participants. The Centre conducted nine batches of training programmes to train 161 participants from 111 institutions as described below:

#### 7.5.1. First Batch, June 16-28, 2003

The inaugural function of the first training programme consisting of 16 participants from 10 institutions in the series was held in conjunction with the inauguration of "Workshop on Website Designing and Hosting" on June 16, 2003. Dr Edward Proctor, Electronic Resources Librarian & Associate Professor, Southwest Missouri University, USA, inaugurated the function. He reminded the library professionals to accept the challenges and make face-lift of their libraries by adopting the latest technologies and appreciated the efforts taken by INFLIBNET to train the working librarians in this direction. Dr T A V Murthy, Director, INFLIBNET, Dr S P Jain, Librarian, GBPAU and Ms. Swati Bhattacharya, Librarian, IIM-Kolkata also addressed the participants on the occasion. ## 7.6. Senior Agriculture Librarian's Workshop

The ICAR-INFLIBNET Workshop for senior agricultural librarians on "IT-Management" was organized by the INFLIBNET, on 4-8 August 2003, under NATP Programme funded by World Bank. Dr S L Mehta, Director, ICAR, along with his team was the source of inspiration. It was inaugurated by Dr R P S Ahlawat, Vice Chancellor, Gujarat Agriculture University, in the presence of Dr T A V Murthy, Director, INFLIBNET Centre and Shri S M Salgar, Scientist-G, at Ahmedabad Management Association Auditorium. Shri H G Hosamani, Shri S S Kushwah and Smt N J Kaku jointly co-ordinated the workshop. There were 18 senior librarians, who participated from various ICAR universities and research institutes. Faculty from the INFLIBNET and other institutes conducted various sessions. Few commercial presentations by E-journal publishers and portals were also included during the workshop. The workshop concluded with drafting of proposals by the committee formed by the participants.

#### 7.7. UGC-Infonet Management Training programmes at ERNET

Seventh Training Programme for the Computer Professionals from Universities covered under UGC Infonet was held during 13-18 October 2003 at ERNET India, New Delhi. Twelve participants attended this programme from selected universities.

Eighth Training Programme for the Computer Professionals from Universities covered under UGC Infonet was held during 2-7 February 2004 at ERNET India, New Delhi. Ten participants attended this programme from selected universities. Shri Meharban Singh, Senior Manager, ERNET India and Shri S K Sharma, Scientist—B, INFLIBNET Centre were the course coordinators for both the training programmes.

## 7.8. Librarian's Day Celebration

Dr S R Ranganathan's birthday was celebrated as Librarians Day on 23<sup>rd</sup> August 2003 jointly organized by ADINET and INFLIBNET by conducting one-day seminar for LIS professionals and students of Gujarat. Shri P C Shah (Hon. Director, ADINET), welcomed and addressed about the mission of ADINET followed by the adage - "Think globally, act locally and commit personally".

Dr TAV Murthy, Director, INFLIBNET Centre, gave the keynote address. He has spoken about the Guru-Shishya Parampara in ancient India. How the knowledge was preserved and disseminated then, and what is the changing scene today. Shri Chandrakant Mehta, Principal, Hiramani School, called Dr Ranganathan, a Maharishi. He raised an important issue of R-Net. He asked when there are so many channels and networks, why not R-net or 'Readers-net'. He said that librarianship is not a profession but a mission. The Guest of Honour, Prof N V Vasani, Adviser, Nirma Education Research Foundation said, "The modern librarians have become information navigators from information dispensers."

#### **Technical Session**

Dr V S Cholin (Scientist-B, INFLIBNET), presented a theme paper on "Consortia for libraries and information centres". Electronic resource sharing can be done very effectively through consortia. He also talked about consortia initiatives established in India like FORSA, CSIR-Consortium, INDEST, UGC-Infonet, etc.

Ms Swadha Majumdar (NID) and Ms Shreyansi Parikh (NIFT), presented a paper on "Digitization of Library Collection". The actual process of digitization needs skilled manpower, special software and hardware. Digitization solves the problem of preserving rare archival material and security. The presentation concluded with presentation of a digitized video clipping of a fashion show.

The post-lunch session started with a quiz programme. Quiz programme was followed by presentation from Shri S R Deshpande (British Library), on "Human Resource Development in Library and Information Centres". HRD requires careful planning, analysis, development and attention in preparing new LIS professionals and refreshing existing ones.

Dr C N Rawal (SP University, Vallabh Vidyanagar), presented a paper on "Training Institutions for manpower developments in library and information science". He talked about the objectives of 10<sup>th</sup> Plan and present scenario of LIS education. He also talked about importance of Continuing Education Programmes, conducted by NISCAIR, DRTC, NISSAT, DESIDOC, INFLIBNET Centre, etc.

Shri S R Yagnik (MICA), presented a paper on "Funding agencies for professional upliftment". He talked about various types of funding available for training, research projects, presenting paper in seminar / conferences, writing books, scholarships, fellowships, etc. The sources to keep updated on such funding are – Newspapers, Newsletters, Directories, Journals, Websites, Personal contact, etc. The day concluded with the report presentation by Shri K M Bhavsar and Prize distribution done by Dr Daksha Surti (Gujarat University).

**SATKAL Award:** Dr. T A V Murthy, Director, INFLIBNET Centre was awarded the prestigious "Punjab National Librarian Award" from Satinder Kaur Ramdev Memorial Trust for Advancement of Librarianship (SATKAL) for the year 2003 for his contribution to the library profession.

Prof. Arun Nigavekar, Chairman, UGC, Prof. V N Rajasekharan Pillai, Vice Chairman, UGC, Dr. TAV Murthy, Director, Information and Library Network (INFLIBNET) Centre, Prof. Ajit Kembhavi, Inter University Centre for Astronomy & Astrophysics (IUCAA) and representatives from various national and international publishing houses, besides eminent academics and UGC officers were present on the occasion. The scheme is wholly funded by the UGC. All universities, which come under UGC's purview, will be beneficiaries of the programme and it will gradually be extended to colleges as well. The first phase of the programme covers more than 50 universities and more universities will join the programme as soon as they get networked in the UGC-Infonet. This programme will cover major research disciplines in the faculties of Arts, Humanities, Science and Social Sciences. The literature includes journals covering research articles, reviews and abstracting databases. Access will be provided to current and

archival literature. Portals will be provided which will enable users to navigate easily through all the research literature. INFLIBNET will administer and monitor the programme and will have independent electronic access to all the publications to help with the process. One free print copy of each journal, subscribed under the consortium by each publisher for archival purpose is provided by many publishers. A website is created to provide all information to the consortium members about the details of the programme. Training programmes will be conducted to spread awareness and to develop expertise in the university community in the use of E-Resources.
