# Staff and LIS Fraternity once again welcomes **Dr Jagdish Arora** who Joined as Director, INFLIBNET Centre for the second term of five years beginning August 31<sup>st</sup>, 2012.



#### From the Director's Desk

I am grateful to the Chairman, UGC for giving me an opportunity to serve the INFLIBNET Centre as its Director for the second consecutive term of five years. The Centre has performed exceedingly well in past five years under able guidance of Prof. S K Khanna, Chairman, Governing Board, Prof. S K Thorat (2006-2011) and Prof. Ved Prakash, President, Governing Council and Chairmen, UGC. The UGC and its key functionaries extended their full support to all our existing projects and new initiatives with liberal finances, resources and manpower as and when required. Moreover, the Centre was given a number of opportunities to prove its mantle with additional roles and responsibilities. I would take this opportunity to acknowledge the team efforts put-in by the INFLIBNET scientists and staff for executing the projects and programmes entrusted to them most effectively and efficiently. I am sure that the help, support and guidance that we have received from the UGC during the past five years would continue. I would also request my colleagues at the INFLIBNET Centre as well as to the entire LIS community for their continuing support to take this esteemed institution to newer heights.

The 2nd and 3rd (Volume No. 19) of INFLIBNET Newsletter is a reflection of multifarious activities that the Centre is involved with. I am happy to inform you that the Centre has been given the responsibility to coordinate technical and administrative activities of e-PG Pathshala, a project assigned to the UGC by the Ministry of Human Resource Development under its National Mission on Education through ICT (NME-ICT). The project envisages developing econtent in 77 subjects using four quadrant approach propounded by the NME-ICT. Moreover, the Centre has also been given the responsibility to coordinate the activity of content creation in the field of Library and Information Science. The Project is progressing well. A National Workshop for all Subject Coordinators and National Coordinators of e-PG Pathshala was organised in the month of August 2012 followed by meetings of the subject coordinators, papers coordinators and content creators in different subjects in the following months of September and October. A number of modules developed under the Project are already available through e-PG Pathshala Learning Management System hosted at the INFLIBNET Centre (http://www.inflibnet.ac.in/epgp/).

The Academic Job Portal for NET, SET and Ph.D-qualified candidates, set-up by the INFLIBNET Centre for the UGC, is doing very well. More than 7,500 eligible candidates have registered themselves on to the portal and have creating their profiles within a short period of two months. Moreover, universities and other institutions of higher learning have started uploading their job vacancies on to the portal.

I am happy to report that the INFLIBNET Centre has signed MoUs on Shodhganga with more than 85 universities and on library automation with 23 universities. The UGC, on recommendation of the INFLIBNET Centre and Committees appointed for these purposes, has allocated funds to universities as well as to the INFLIBNET Centre as per the details given below:

i) 39 eligible universities, signatory to the MoU on Shodhganga with INFLIBNET Centre, have been allocated funds for the digitization of backfiles of theses as well as for setting-up of an ETD Laboratory. The Shodhganga repository now hosts more than 4,100 Ph.D. theses.

- ii) 23 universities, signatory to the MoU on Library Automation with INFLIBNET Centre, were allocated funds for retro-conversion of bibliographic records of documents available in their libraries as well as for purchase of hardware including servers and PCs.
- iii) INFLIBNET Centre was allocated funds for purchase of hardware and recruitment of contractual manpower for Shodhganga as well as for subscription to an anti-plagiarism software for universities.

An induction programme was organised for librarians / their representatives at the INFLIBNET Centre wherein the participants were reminded of their roles and responsibilities for contributing bibliographic records of their respective libraries to the IndCat, the INFLIBNET's Union catalogue. Presentations were made by the INFLIBNET's scientists on library automation, data conversion, bibliographic standards, and Online Copy Catalogue System, etc. The Centre would also be organizing a workshop for representatives of universities that have signed MoU with the INFLIBNET Centre on Shodhganga to evolve guidelines for digitisation of theses and dissertations, for uploading theses into Shodhganga and for setting up ETD laboratory in their respective universities.

The Centre's services, activities and achievements have caught the attention of the Ministry of Human Resource Development as well as that of Human Resource Minister. The Director, INFLIBNET Centre was requested to make a presentation on the activities and services of the INFLIBNET Centre to Shri Kapil Sibal, Hon'ble Minister of Human Resource Development on 1st July 2012. The Minister and other high officials, after viewing the presentation put their appreciation on records for the efforts put in by the Centre. Consequent to the presentation made by the Director, the Ministry set-up a Committee to consolidate and expand consortia initiative for all institutions of higher learning. I would like to make a special mention about the N-LIST programme that was selected for presentation to the Apex Body of NME-ICT chaired by Shri Kapil Sibla, Hon'ble Minister for Human Resource Development. The Minister desired that the programme may further be extended to all colleges including medical, technical, agriculture, pharmacy and other institutions with inclusion of requisite resources required by these institutions.

The INFLIBNET Centre, collaborated with JSTOR, one of the important resources being subscribed under the UGC-Infonet Digital Library Consortium, to organize JSTOR User's Forum, one in Delhi and other in Bangalore on 4th and 6th September 2012 respectively. The programmes were highly successful and were well attended by a large number of Librarians and users both the in Delhi and Bangalore. I am happy to inform to the user community that the JSTOR would also be included in the N-LIST Programme and member colleges would have access to JSTOR through N-LIST Programme very shortly.

Human Resource Development and SOUL Software are two flagship programmes of the Centre. Three training programmes were organised on SOUL 2.0 at the INFLIBNET Centre for librarians and computer professionals and seven user awareness programmes were organised for universities and colleges on e-resources being offered under the UGC-Infonet Digital Library Consortium and N-LIST Programme during the period under report. The Centre also collaborated with Jawaharlal Nehru University for organising a 5- day Workshop on setting-up of Institutional Repository using D-Space from 23rd to 27th July 2012. A National Workshop of Intellectual Property Rights and Copyright was organised in collaboration with Mizoram University, Aizwal from 27 and 28th August, 2012.

This issue of the Newsletter features a special article entitled "Assessing and Evaluating Research Performance of an Institution using Bibliometric Indicators". The article elaborates on bibliometric indicators that can be used to evaluate performance of universities and other institutions of higher education. I am sure that the user would find the article interesting and informative.

The participants were asked various questions about availability of e-resources, accessibility, use and preconditions of the N-LIST Project. The technical sessions were followed by the distribution of certificates of participation and ended with the vote of thanks proposed by Mr. John Landge.

In the inaugural speech, he described the state of affairs of libraries in general. He stated that libraries fall in the domain of public good and, therefore, the sensibilities and onus about it is required to be developed. Dr. P. R. Goswami, Director, National Social Science

Documentation Centre (ICSSR) graced the occasion as Guest of Honour. In his address, he traced the evolution of e-resources from electronic CDROM database to the online full-text resources. He stated that with the advent of Internet, access have been revolutionized and become far easier. He elucidated distinction between the dissemination of information services in social sciences with that of sciences, as social sciences always have a geographical and chronological connotation while sciences are universal in nature. A formal welcome address was given by Dr. Vikas Gupta, Deputy Registrar, University of Delhi South Campus (UDSC). He emphasized on the need for such programmes to derive maximum benefits from the available resources. He stated that networking of libraries and collaborative strategies in acquisition of e-resources are the key to empower both libraries as well as the user communities. Shri R. N. Vashista, University Librarian, DULS stressed upon the role of libraries and librarians to maximize utilization of e-resources. He asked library professionals to develop passion to understand contours of knowledge. Dr. Tariq Ashraf extended a warm vote of thanks at the end of inaugural session.

#### **Technical Sessions**

The core agenda of the programme was set in motion by Mr. Ashok Rai, Scientist D (CS), INFLIBNET Centre, who gave an overview of N-LIST programme. He briefly described N-LIST as a new initiative of MHRD under its National Mission on Education through ICT. He spoke about the resources offered by N-LIST, i.e. no. of e-books/e-journals, search features, back file access, perpetual access rights in a live demonstration through

N-LIST website. Representatives of the following publishers made presentations on e-resources offered by them to the colleges under N-LIST programme:

i) Ebrary: 70,000 e-books

ii) AIP/APS: 18 journals with 10 years backfiles

iii) Springer: 1500 electronics books

iv) Taylor & Francis: 1000 electronics books

v) MathSciNet: Mathematical Reviews from 1940 onwards

vi) IndianJournal.com: 150 Indian journals

### Panel Discussion on "Print to Electronic: Changes, Challenges & Strategies"

Panel Discussion was chaired by Professor Sanjay Kapoor, Department of Plant Molecular Biology, UDSC. The panalists were: Mr. Kailash Balani (M.D. Balani Infotech), representing publisher, Dr. Sanjeev Singh, an ICT expert and Mr. Saleem Anwar, a library expert. The panel discussion started with the key remark made by Prof. Kapoor enlisting the core areas for discussions including faster access, better search capabilities, better ICT inability, availability of more content, robustness of search engines, database organization and design as per users' need, requirement of research and requirements of publishing in e-environment.

Shri Kailash Balani described the transition from print to electronic and virtual form of information needs of users and its acceptance by libraries and communities at large. He said that publishers in India are operating at a little margin which is compensated by the volume in Indian market. Publishers offer their product on trial basis for 3 to 6 months. He justified the marginal percentage increase in cost of subscription on annual basis. Dr. Sanjeev Singh talked about cloud computing for seamless access of content. According to him, libraries require sound ICT infrastructure and support to devise and deliver their key services. He threw light on development of open coursewares under creative commons license. He stressed that there is also a need for producing quality content while checking plagiarism through software such as Turn-It-In etc.

The last panelist, shri Saleem Anwar spoke on the shift that has happened in journals' subscription model. He talked about purchase procedures, negotiation strategy, financial rules & regulation, restrictive terms of access, annual price cap, etc. with respect to e-journals databases acquisitions. The panel was summed up with a recommendation that

"Librarians and users together should rationalize and justify purchase of resources and their usage".

The proceedings on the second day started with a presentation by Shri Rajesh Singh, Deputy Librarian, Central Reference Library, University of Delhi on "Online Search Techniques". He covered the topic very comprehensively via-a-vis databases subscribed by DULS under UGC-Infonet Digital Library Consortium. He dwelt deep into availability of abundant free web resources and subscribed databases. He also covered Scopus database and deliberated upon its unique features of citation analysis and evaluation of researchers'/authors' profile.

The next session consisted of presentation from publishers and their representatives on e-resources. The presentations were made by Elsevier Science on Science Direct, Web of Science on citation indices, GIST-find, Infomatics India on JCCC, M/s. Balani Infotech on Project Muse, ACS and SIAM, Sci-Finder, Wiley Blackwell and Oxford Journals.

The last presentation of the two days awareness programme was delivered by Dr. S.C. Jindal, Deputy Librarian & In charge, Central Science Library, University of Delhi, on "Orientation to DULS subscribed e-resources both individually and through the consortia". The presentation covered description of many useful free web resources as well as search engines in open domain.

#### **Valedictory Session**

The valedictory session was chaired by Prof. Indranil Dasgupta, Dean, Faculty of Inter-Disciplinary & Allied Sciences, UDSC. Prof. Dasgupta, in his closing remark, said that availability of e-resources has made a remarkable impact on teaching-learning and research activities which is a very welcome development. Earlier, the imperative was to publish or perish which has now become patent or perish.

Dr.Tariq Ashraf, Programme Co-ordinator expressed his sincere thanks to Dr.Jagdish Arora, Director, INFLIBNET Centre for providing support in organising the awareness programme. He thanked Shri Ashok Rai for his presence and making the valuable presentation. Dr. Ashraf further thanked all the publishers, vendors and participants for their participation and contributions in making programme successful.

## National Workshop on "Intellectual Property Right with Reference to Patents and Copyrights

National Workshop on "Intellectual Property Right with Reference to Patents and Copyrights, Mizoram University, Aizawl, 27th-28th August, 2012

A two-day National Workshop on 'Intellectual Property Rights with Reference to Patents and Copyrights' was organized by the Department of Library and Information Science, Mizoram University, Aizawl in collaboration with INFLIBNET Centre, Ahmedabad and DRDO, New Delhi on 27th August, 2012. The Inaugural Session commenced with an offering of bouquet to Chief Guest Prof. A K Agarwal, Head, Dept. of Economics and incharge Vice-Chancellor, Mizoram University, Chief Speaker Prof. Thangchungnunga, Registrar, Mizoram University, Aizawl presided over the inaugural function. Prof. Pravakar Rath, Head of the Department, Prof. R K Ngurtinkhuma, Coordinator and the distinguished guests on the dais and the participants offered floral tributes to the portrait of Dr. S R Ranganathan to commemorate his outstanding contributions to the library sicence. Prof. Pravakar Rath, Head, Department of Library & Information Science welcomed the participants, dignitaries, deans, head of the departments, faculty, research scholars, and other invitees. Prof. Rath, in the brief introduction, highlighted the importance of National Workshop on Intellectual Property Rights and

Copyrights. In his speech, he pointed out the significance of copyright in academic institutions and emphasized on citations/references in the literary output. He mentioned the role of librarian for adhering to the copyright and licensing. Prof. A K Agarwal, Head, Dept. of Economics and in-charge Vice-Chancellor, Mizoram University, in his speech, elaborated about the importance of workshop to faculty and research scholars. He pointed out the relevance of IPR and copyright in the library. Prof. Agarwal mentioned the crucial role of the library for adhering to the licensing policies and faculty while guiding research scholars to strictly follow the norms of copyright. Prof. Thangchungnunga, Chief Speaker, & Registrar of Mizoram University, in his address, discussed the role of university teachers to maintain legal issues of copyrights while guiding research scholars. He mentioned the changing role of libraries in the electronic environment. He opined that the library professionals must adhere strictly to the principles of copyright and take measures to protect the intellectual output of the university. Prof. R K Ngurtinkhuma offered a vote of thanks to the university, participants as well as to the INFLIBNET Centre. 40 participants attended the workshop including librarians, faculty and research scholars.

#### **Technical Sessions**

The first technical session commenced with the presentation of Dr. (Mrs) S. Banerjee from L. S. Davar & Co., Kolkota on 'Patent Laws and its application in Indian scenario'. She focused on the national and international scenario of patents and the role of library in preserving the patents.

In the second technical session Dr. V S Thomas, University Librarian, W.B. National University of Juridical Sciences, Kolkata made a presentation on 'Copyright Laws in India and its Application in the Electronic Environment'. Dr. Thomas mentioned about the copyright and the role of librarians. He emphasized on the citation of the referred documents by the research scholars and faculty while writing the research paper. He further mentioned that the citation must be according to the specific citation style followed in bibliography.

The third technical session on the second day of the workshop began with a lecture by Dr. Swati Bhattacharva, Librarian, IIM, Kolkota on 'IPR and Copyright-Adopting Best Practices in Libraries'. She stated that Intellectual property shares many of the characteristics associated with real and personal property. She further mentioned that intellectual property is an asset, and it can be bought, sold, licensed, exchanged, or gratuitously given away like any other form of property. Further, the intellectual property owner has the right to prevent unauthorized use or sale of the property. The fourth presentation was made by Dr. Moortimatee Samantary, Head, LDD, NCERT, New Delhi on 'Copyright vs Authors, Publishers and Librarians'. She mentioned that copyright is an exclusive right to reproduce an original work of authorship fixed in any tangible medium of expression, to prepare derivative works based upon the original work, and to perform or display the work in the case of musical, dramatic, choreographic and sculptural works.

Presentations were concluded with an interactive discussion among the participants and faculty.

# Panel Discussion on 'Protecting Intellectual Output in a Knowledge Society'

The panelists were Prof. J K Patnaik, Dr. Swati Bhattarcharya, Dr. M. Samantaray, Prof. P K Rath and Prof. R K Ngurtinkhuma. Prof. Patanaik highlighted several prominent issues on Intellectual Property Rights. He mentioned about the authors' right in intellectual output and also expressed that copyright protection does not extend to any idea, procedure, process, system, method of operation, concept, principle, or discovery, regardless of the form in which it is described, explained, or embodied. Dr. Swati Bhattarchaya elaborated on patents as intellectual property, Dr. Samantaray discussed on copyright prevailing with authors and highlighted the laws passed by the Govt. of India in 2012. Prof. R K Ngurtinkhuma mentioned the primary issues on patents for trade and highlighted its relevance in libraries. Prof. P K Rath while answering to the questions from the participants pointed out that copyright and patents play an indispensable role in the libraries. He discussed about the protection of the intellectual property of the institutions, authors, etc. The workshop concluded with a lively discussion among the panellists and participants.

The Director, INFLIBNET Centre made a presentation on INFLIBNET Centre, its services and activities to the Shri Kapil Sibal, Honourable Minister of Human Resource Development on 1st July, 2012 in his chamber at MHRD, Shashtri Bhawan, New Delhi. Besides the HRM, Prof. Ved Prakash, Chairman, UGC, Shri Ashok Thakur, Secretary (HE), Shri V Uma Shankar, Joint Secretary and PS to the HRM, Shri R P Sisodia, JS (HE) and Shri Amit Shukla, Dy. Secretary (HE), MHRD also attended the presentation. The Hon'ble Minister took note of the services and activities of the Centre and appreciated the new initiatives taken by the Centre including N-LIST, OJAS, Shodhganga, Shodhgangotri, etc. He desired that the INFLIBNET Centre should take a lead in consolidating the consortia initiatives in India to benefit larger cross-sections of colleges, universities and institutions of higher learning.

### N-LIST: Current Status and New Developments

# National Workshop on "Intellectual Property Right with Reference to Patents and Copyrights, Mizoram University, Aizawl, 27<sup>th</sup>-28<sup>th</sup> August, 2012

The N-LIST Programme has registered a total number of 2,854 colleges as on September 30, 2012, including 2,610 eligible colleges that are already getting access to resources subscribed under the N-LIST programme. Login IDs and passwords have been issued to more than 3,75,000 faculty members, students and researchers after obtaining list of authorized users from these 2,610 registered colleges. Group login ID and passwords have also been issued to colleges awaiting list of actual users.

#### **Resource Selection for N-LIST**

The Second Meeting of the Resource Selection Committee for the N-LIST was held on June 22, 2012 at Central Library, IIT Delhi. 11 publishers / their representatives were invited to make presentation on electronic books that they wish to offer to the colleges covered under N-LIST programme. Each publisher / their representatives were asked to make a detailed presentation on their e-book collection, its size, category of books covered, major features and functionalities of the hosting platform, etc. After detailed discussions and deliberations, it was agreed that additional number of titles may be added from the following publishers whose electronic books are already available under the N-LIST programme since past one year: i) Cambridge University Press ii) Oxford University Press iii) Springer and iv) Taylor & Francis.

It was also agreed that the negotiations for purchase of e-books from the following two publishers may be carried out since both the publishers have good quality e-books suitable for the colleges: i) Sage Publications and ii) McGraw Hill India Education Pvt. Ltd.

After detailed discussions and deliberations, it was agreed that the e-book collections offered by the following publishers / aggregators should be evaluated by the members of Resource Selection Committee for the content being offered by them. The members of the Resource Selection Committee were given user-ID and password to access these resources for evaluation purposes:

- i) General Social Science Collection (e-books from 6 university presses and 5 other societies) offered by iGroup
- ii) EBSCO-NetLibrary
- iii) World Technology on My-i-Library Platform offered by Swet
- iv) Palgrave Macmillan
- v) Pearson Education

Based on the feedback from the members of the Resource Selection Committee, it was agreed that selected publishers / aggregators from the above mentioned publishers may be called for negotiations.

# Presentation on N-LIST to the Apex Body of NME-ICT by Dr. Jagdish Arora, Director, INFLIBNET Centre on 2<sup>nd</sup> July, 2012

The project "National Library and Information Services Infrastructure for Scholarly Content (N-LIST)", being executed jointly by the INFLIBNET Centre and IIT Delhi was selected for a special presentation before the Apex Body of NME-ICT chaired by Shri Kapil Sibal, Hon'ble Minister, Human Resource Development on 2nd July, 2012 in Habitat Centre, New Delhi. Dr. Jagdish Arora, Director, INFLIBNET Centre made the presentation as Co-PI of the project on resources offered implementation methodology, economics, cost effectiveness and current status of N-LIST. The members took note of the honours and awards bestowed onto the INFLIBNET Centre for N-LIST Project. The Hon'ble Minister desired that the access to e-resources under the N-LIST programme should also be extended to professional colleges including engineering, management, agricultural, medical colleges, etc. with inclusion of appropriate resources.

### e-PG Pathshala: Current Status and New Development

The MHRD, under its National Mission on Education through ICT (NME-ICT), has assigned work to the UGC for development of e-content in 77 subjects at postgraduate level. 36 subjects have been identified for the development of e-content in 1st phase.

A Learning Management System (LMS) has been set-up at the INFLIBNET Centre on a dedicated server that is available in open access at http://www.inflibnet.a.in/epgp.

Currently the process of identification of papers in each subject and modules in each paper is in progress. The content for the subject Botany (01 module), Computer Science (01 module), Environmental Science (01 module), Library Science (2 modules) and Political Science (01 module) have been developed and uploaded on the Learning Management System.

# Responsibility of E-content Creation in Library & Information Science at Postgraduate Level assigned to the INFLIBNET Centre under e-PG Pathshala

The Standing Committee on Production of Courseware E-content for Postgraduate Subjects appointed Dr. Jagdish Arora, Director, INFLIBNET Centre as Subject Coordinator for the Library and Information Science and assigned the responsibility for developing e-content in Library and Information Science at PG level to the INFLIBNET Centre. Under this initiative, the Centre would develop 560 e-modules in 16 papers of Master in Library and Information Science (2 years integrated course). The Centre has earlier been assigned the responsibility for technical and administrative coordination of e-PG Pathshala with financial support from MHRD under the National Mission of Education through ICT.

Workshop on e-Content Development for PG Courses for National Coordinators and Subject Coordinators under e-PG Pathshala, Institute for Studies in Industrial Development, New Delhi, 18th August 2012

One-day National Workshop on Content Creation for National Coordinators and Subject Coordinators, e-PG

Pathshala was organised by the Information and Library Network Centre in collaboration with University Grants Commission on 18th August, 2012 at Institute for Studies in Industrial Development (ISID), New Delhi. Prof H P Dikshit, National Coordinator, e-PG Pathshala delivered the welcome address during the Inaugural session. Prof R G Harshe, National Coordinator, e-PG Pathshala in his address to the particpants, introduced theme of the workshop and highlighted its objectives. Prof M. Anandakrishnan, Chairman, Standing Committee, e-PG Pathshala graced the occasion as a Guest of Honour and delivered a talk on status and important of e-learning in higher education. Prof. Anandakrishnan, in his presentation, touched upon various aspects of e-learning and its benefits with respect to interdisciplinary exposure to the students. He stated that virtual education is booming due to the technological Darwinism and elearning would provide a platform to the student to absorb difficult concepts on their own. Prof Ved Prakash, Chairman, University Grants Commission and Chairman, Programme Implementation Committee, e-PG Pathshala, in his inaugural address, lauded the efforts made by the INFLIBNET Centre in organising such a programme for the benefit of National Coordinators and Subject Coordinators so as to familiarise them with various processes involved in the process of e-content development. Prof Ved Prakash highlighted a number of critical crises in the higher education system in India including identity, governance and resources. He emphasised that it is the responsibility of higher education system to provide self-leaning course materials through e-PG Pathshala that should reach not only to urban population but also to rural part of India to fulfil the growing needs of the students. Dr Jagdish Arora, Director, INFLIBNET Centre delivered a warm vote of thanks to authorities in UGC, Chairman and member of the standing committee as well as to the participants.

During the Technical Session, Prof A K Bakhshi, National Coordinator, e-PG Pathshala, delivered lecture on econtent development process and explained role and responsibilities of National Coordinators and Subject Coordinators. Dr Vimal Rarh, Assistant Professor, Khalsa College, New Delhi made a presentation on input and output template and various standards to maintain uniformity of the course content. Dr Jagdish Arora,

Director, INFLIBNET Centre, in his presentation on responsibilities of INFLIBNET Centre and activities involved in production of course content like content collection, multimedia enrichment, hosting on the LMS, document management etc. Dr. Archana Thakur, Deputy Secretary, University Grants Commission, in her presentation, described about guidelines and payment norms to the Content Development Team.

More than 45 participants attended the workshop including National Coordinators, Subject Coordinators and Paper Coordinators. Feedback session held in the afternoon was chaired by all the members of Standing Committee, where in participants raised question on following issues:

- 1. Standard style manual for content writer (fonts, line space, table, picture and references)
- 2. Issues related to implementation of four Quadrant approach specially for social science and arts subjects
- 3. Standard syllabus for all the papers based on the current trend
- 4. Classification of subjects, papers and modules based on international standard
- 5. Defining standard workflow and procedures for reviewing, monitoring, possibility to appoint

- more reviewers
- 6. Providing assistance to subject coordinators for admin work (Keying-in and formatting)
- 7. Separate workshop for subject or group of similar subjects regarding template, storyboard writing incorporating multimedia in the content, reference to the other content, copyright issues
- 8. Guideline on procedure to be followed by subject coordinator to appoint paper coordinators and content writers
- 9. Availability of content in regional languages
- 10. Difficulties to develop course content for social work education (particularly for the field work)
- 11. Provision of interdisciplinary coordinators for interdisciplinary subject (Botony, zoology, biotechnology)
- 12. More module for interdisciplinary subjects (45 instead of 35)

While answer to some of the questions were given instantly on the spot, the member of the Standing Committee assured the participants that issues that have not been addressed to will be taken up in the next meeting of Standing Committee to come up with appropriate solution for all the issues flagged by the participants.



### **UGC** Infonet University Forum

#### UGC Infonet University Forum, 13th June 2012

The 3rd University Forum, organized by INFLIBNET Centre and Elsevier Science was held at the Taj Mahal Hotel, New Delhi on 13th June 2012. 

# Assessing and Evaluating Research Performance of an Institution using Bibliometric Indicators Jagdish Arora and Kruti Trivedi

The author of the article, Jagdish Arora, Director of the INFLIBNET Centre and Kruti J Trivedi Scienctist, B(LS), INFLIBNET Centre explains methods and metrics for assessing and evaluating research performance of an institution using Bibliometric Indicators. The paper highlights some of the underlying principles and metrics that are used for evaluation of research performance. It also provides background information to assist the universities / institutions to conduct evaluation of research performance. Ms. Kruti J Trivedi is looking after N-LIST Programme and UGC-INFONET Digital Library Consortium. She is also involved in measuring research output of member universities. #### 1. Introduction

The generation and transmission of knowledge through research has long been recognized as an essential requirement for a country's long-term growth and competitiveness as well as for creating capacity to solve social problems (World Bank, 1998). Considering the fact that the benefit of increasing research output and potentiality to increase economic growth, many governments, regulatory bodies and funding agencies have increased research funding to universities. Since funding for research to a university should logically commensurate with its research output, there is a need to identify performance indicators for qualititative evaluation of research output. These performance indicators are being used as a tool to find out research performance of a university as well as to determine funding allocations. The main focal points of research evaluation are productivity, quality, impact, and utility of research output in terms of generating technological, economical or social benefits. Qualitative parameters and performance indicators are being evolved to measure all these different aspects of research evaluation. As regards to assessment methods, the literature on research performance shows that bibliometric analysis and peer review are the main approaches for assessing the quality and impact of research. In this paper, we outline the need for university research assessment, types of performance indicators and metrics that can be used, particularly in relation to research within universities.

#### 2. Need for Assessments of Research Output

There are a number of reasons to justify assessments of government funded research in present era. The first and foremost reason is ever growing cost of conducting planned research that includes cost of subscription to peer review literature, scientific instrumentation and infrastructure that are required to conduct research. As universities spends huge amount to set-up research facilities, it becomes necessary for the university to evaluate status of their comparative research performance. Moreover, on an average Government funding for R&D is increased 5% to 10% every year. Performance indicators are used not only to identify new areas of research and researchers for fund allocation but also to identify declining areas of research. Furthermore, evaluation of research performance is also an issue of social responsibility and accountability. Research evaluation assures Government and public that their contributions are being well spent. Universities are expected to become more efficient in their use of public resources and more accountable (Massy, 1996). In US, the Government Performance and Results Act was passed in 1993, which requires federal agencies to establish strategic planning and performance measurement. This, in turn, requires the establishment of performance goals and performance indicators to assess output, service level and outcome. Research assessment also enable research funders and policy makers to make better decisions about funding, ranking, awards, promotion, benchmarking, etc. There are three reputed

globally-recognized rankings of the world universities, namely i) Shanghai Jiao Tong University's Academic Ranking of World University; ii) Academic ranking of world universities compiled by the QS World University Ranking; and iii) Times Higher Education World University Ranking. All these three "rankings" have used different sets of indicators and parameters for ranking the universities. Apart from all other parameters, research performance is one of the major and high weightage indicators to identify ranking of World class University. It is, therefore, important for a university to evaluate their research strengths and weaknesses and prioritize research areas to formulate a strategy for future work

#### 3. Bibliometric Indicators

Bibliometric indicators are generally used to assess the status of research performance across institutions and geographical regions/countries. It addresses the issues such as: (i) Is a University contributing more or less to research output in a particular field or sub-field in comparison to other universities? (ii) Is it performing better than others?, and (iii) Is it contributing more research output in a particular area compared to others? Two types of indicators, namely absolute and relative indicators are generally used for bibliometric analysis. Publications count, journals count, and citations count, etc. are the examples of absolute indicators. These are used frequently for bibliometric analysis. On the other hand, activity index (AI), and relative citation Index (RCI) are examples of relative indicators, which is used to assess the strengths and weaknesses of a university on relative basis. For example, activity index of a university, e.g. University of Delhi, in a particular subject field, e.g. Chemical Sciences, can be used to compare publication activity against average publication activity of the country, which is taken as the benchmark for comparing publications activity of various universities. It can also be used to identify research priorities of different countries or regions within the country. It also helps to understand the strength of the university in various subjects (NISTADS, 2006). Various indicators used for measuring the publications and citations output of the university, institute, geographical region or country across disciplines are described below..

#### 4. Measuring Growth of Research Publication of an Institute

Number of research papers published in peer-reviewed journals is a reasonable measure of research productivity. It provides an estimate of the productivity of research and related knowledge generation. The indicator defines the level of scientific progress made by an individual, institute, group, university or country.

#### **Publication (P):**

Total number of papers published by the research institutes for a given period. Number of Publications (P) can further be used to determine:

#### ➤ AGR (Annual Growth Rate):

AGR provides average increase in number of publications over a period of 5, 10 or more years. This metric is a used to measure the growth of publications in different subject areas over a period of time for a given university or set of universities. AGR is calculated using the following formulae:

❖ For Example:

Years No. of Publications
$$1971-1980 = 429$$

$$1981-1990 = 706$$

$$1991-2000 = 1031$$

$$2001-2010 = 1391$$

$$AGR = \frac{(706-429)}{429}*100 / 10 = \frac{277}{429}*100 / 10 = \frac{64.57}{10} = 6.46\%$$

$$AGR = \frac{(1031-706)}{706}*100 / 10 = \frac{325}{706}*100 / 10 = \frac{46.03}{10} = 4.60\%$$

$$AGR = \frac{(1391-1031)}{1031}*100 / 10 = \frac{360}{1031}*100 / 10 = \frac{34.92}{10} = 3.49\%$$

#### ➤ AAGR (Average Annual Growth Rate):

Average value of Annual Growth Rate (AAGR) for different period is calculated using the formulae given below.

(Growth Rate in Period A + Growth Rate in Period B + Growth Rate in Period C + ... Growth Rate in Period X)

❖ For Example:

$$AAGR = \frac{6.46\% + 4.60\% + 3.49\%}{3} = \frac{14.55}{3} = 4.85\%$$

#### 5. Measuring Impact of Research Output

Impact of a research article can be measured by the number of citations received by it. Likewise, impact of a research institute can be measured in terms of cumulative number of citations received by all research publications authored by its faculty and researchers. The area of study that deals with evaluation and interpretation of number, frequency and pattern of citation reviewed by articles, scientist, universities, counties, etc is called citation analysis. Aim of citation analysis is to estimate impact made by publication of a scientists, institution or a country. A citation is an abbreviated alphabetic expression embedded in the body of an intellectual work that denotes an entry in the bibliographic reference section of the work for the purpose of acknowledging the relevance of the works (Wiki). The citations provide an idea about the utilization of published knowledge. It is considered that frequently cited paper have greater impact to influence subsequent research activities then a paper with no citations. Citation analysis studies that can be conducted to measure performance of an institute is as follows:

#### ➤ Citations with Self Citations:

The number of citations of all articles of a university including self-citations (publications of a university citing themselves).

#### ➤ Real Average Citations:

This metrics is used to assess quality of research publications across different subject areas, universities, and geographical regions, etc. The formulae for calculating Real Average Citations is:

#### For Example :

Out of 3,557 publications of a university, 2753 publications have received 24165 citations, in this case Real Average Citations is:

Real Average Citations: 
$$\frac{24165}{2753} = 8.78$$

#### ➤ Cited rate:

Cited rate provides percentage of publications that have been cited at least once during pre-defined time period. The cited rate is calculated using following formulae:

#### For Example :

Out of 3,557 publications of a university, 2,753 publications have received 24,165 citations, in this case cited rate is:

Cited rate = 
$$\frac{2753}{3557}$$
 \* 100 = 0.7739\*100 = 7.40%

➤ Percentage of Publications not Cited (PNC): This metric provides percentage of publications not cited during a specified time period. PNC is calculated using following formulae:

#### For Example:

Out of 3,557 publications of a university, 2,753 publications have received 24,165 citations, in this case percentage non-cited publication is:

$$PNC = \frac{(3557-2753)}{3557} *100 = \frac{804}{3557} *100 = 0.2260*100 = 22.60\%$$

#### ➤ HIndex:

The Hirsch index, or H-index, is a distribution-based indicator that corresponds to the number of papers at or above a given citation level equal to the value of the citation. This metric reflects the number of papers (N) in a given dataset having N or more citations (Thomson Reuters, 2008). For example, an H Index of 77, indicates that 77 papers in the given set were cited at least 77 times each. This metric attempts to reflect both productivity (number of papers) and impact (number of citations) by a single number. This metric is useful because it discounts the disproportionate weight of highly cited papers, or papers that have not yet been cited.

#### 6 Analyzing Active and Passive Areas of Research

#### ➤ Relative Specialization Index:

The Relative Specialization Index (RSI) compares the shares of subject disciplines in university's total publications to the overall shares of each subject discipline in world's total publications. The RSI is a relative indicator which is based upon the Activity Index (AI). The formulae for calculating Activity Index is:

The RSI is then calculated using Activity Index as follows:

$$RSI = \frac{AI - 1}{AI + 1}$$

#### For Example:

If, Total Number of Publications of the World in Engineering and Technology = 53,68,118 and Total number of Publication of a University in Engineering and Technology = 3557

Data Sorted by

$$AI = \frac{3557}{53,68,118} = 0.0007$$

Now,

$$RSI = \frac{0.0007 - 1}{0.0007 + 1} = \frac{-0.9993}{1.0007} = -0.9987$$

RSI takes its values in the range -1 to < 1. The value indicates whether a university has a higher-than-average activity in the world in a scientific field (RSI > 0) or a lower-than-average activity (RSI < 0). RSI = 0 reflects a completely balanced situation. It also reflects a certain internal balance among the fields at the given university; positive RSI values must always be balanced by negative ones, as no university can have only positive RSI values.

#### 7 Measuring Collaboration

Research collaboration can be defined as working together of researchers to achieve the common goal of producing new scientific knowledge. Research collaboration requires work in partnership with other research investigators including government departments and agencies, universities and colleges, and industry. It extends across disciplines and organizational boundaries. Metrics of this indicator are used to measure share of collaborative activity of university and compare it with other institutes, country and world.

**Collaboration Index** is a relative measure of the collaborative activity of an institution. It is measured using following formulae:

#### For Example:

If, university collaborates 1260 papers out of 5,286 total publications in area of medical and health sciences and India collaborates 8569 papers out of 16085 total publications, in that case Collaboration Index is:

Collaboration Index =

**International Collaboration Index** is a relative measure of the collaborative activity of an institution at international level. It is calculated using following formulae:

#### For Example:

If, university collaborates 750 papers out of 5,286 total publications in area of medical and health sciences and India collaborates 4587 papers out of 16085 total publications, in that case Int. Collaboration Index is:

Int. Collaboration Index =

#### 8. Measuring Correlation

The correlation analysis, a statistical technique, is deployed for measuring the strength of association between two random variables. Two sets of data are said to be correlated when any change in one set of data accompany by corresponding change in other. The relative degree of intensity of association between two variables is measured by correlation coefficient. The correlation coefficient is a ratio that expresses the extent to which the two variables are accompanied by the change in concerned variable. The value of correlation coefficient ranges from -1 to +1. When there is a perfect positive correlation, the value of correlation coefficient is equal to +1 and it is -1 in case of perfect negative correlation.

There are a number of methods to calculate correlation coefficients can be calculated. The two most commonly used are Pearson's correlation coefficient and Spearman's rank correlation coefficient. Pearson's correlation coefficient requires both variables to be measured on an interval or ratio scale, and the calculation is based on the actual values. Spearman's rank correlation coefficient requires data that are at least ordinal and the calculation, which is the same as for Pearson's correlation, is carried out on the ranks of the data. Each variable is ranked separately by putting the values of the variable in order and numbering them: the lowest value is given rank 1, the next lowest is given rank 2 and so on. If two data values for the variable are the same they are given averaged ranks.

#### 9. Summary

Evaluation and measurement of research performance is an important input for policy maker that require transperent and objective evaluation tools and techniques. The objective of this paper is to provide background information to assist the universities / institutions to conduct evaluation of research performance. The paper highlights some of the underlying principles and metrics that are used for evaluation of research performance. First part of the paper indicates needs of assessment of an institute using using of bibliometric indicators for measuring research performance of institute. Paper proposes various formulae and examples related to these indicators. While, this paper restrics itself to enlisting bibliometric indicators for measuring research productivity, there are a number of other parameters that are using for evaluating research performance of an individual or an institute. These indicators include i) institutional strengthening, ii) funds allocation iii) research infrastructure iv) quality assurance v) honours and awards received, etc. A seperate paper will be published highlightling all these performance indicators used for performance evaluation of a university in forthcoming issue of this newletter.


