From Director's Desk



The last quarter of the year kept us busy in planning for new projects and programmes that the Centre should take-up during XII Plan Period as well as for sustaining ongoing programmes and projects. Consistent efforts are being made to continue UGC-Infonet Digital Library Consortium, one of the flagship programmes of the UGC as well as INFLIBNET Centre, during XII Plan Period. We are very hopeful that with consistent efforts made by the INFLIBNET Centre and UGC, the programme would continue in the next Plan. A project entitled "Integrated e-Content Portal" was submitted for consideration of the Standing Committee of the National Mission on Education through Information and Communication Technology (NME-ICT). The project proposes to host all content created under the NME-ICT on a long-term basis beyond the active period of NME-ICT. The preliminary discussions with the Standing Committee of the NME-ICT where successful, we do hope that this prestigious project would finally be awarded to the INFLIBNET Centre. Another Project entitled "Vidwan: an Expert Database" was successful defended by the scientists of the Centre in the Standing Committee of the NME-ICT. The Standing Committee of the NME-ICT recommended the project with a total outlay of Rs.52.70 lakhs for approval of the Project Approval Board.

During the quarter under report, four SOUL 2.0 Training Programmes including one in-house training programme were organized. Moreover, three INFLIBNET Regional Training Programme on Library Automation (IRTPLA) was organized during this quarter, one each in Dr. Babasaheb Ambedkar Marathwada University, Aurangabad; University of Kalyani, Kalyani; and University of Kota, Kota (Rajasthan) in the month of November & December 2013 respectively. All the three programmes were highly successful. Representatives from INFLIBNET Centre as well as from other universities served as faculty for these three programmes.

Shodhganga one of the most important open access initiatives of the INFLIBNET Centre grew both in terms of number of theses deposited in the repository as well as number of universities who have signed MoU with the INFLIBNET Centre. Numbers of theses in the repository have grown to 12,050 as on 31st December, 2013. During the quarter under report, 11 universities have signed MoU with the INFLIBNET Centre. Shri N V Satyanarayana, Chairman, Informatics India Limited, during his visit to the INFLIBNET Centre uploaded 10,000th theses into Shodhganga on 22nd October 2013. Two Awareness Programmes on Shodhganga were organized one at Jamia Hamdard University, New Delhi and another at Aligarh Muslim University, Aligarh in the month of December, 2013. Training on the process of uploading of theses was imparted to the researchers during these two programmes. Both the programmes were well-attended and appreciated. A series of meetings and presentations were made for selection of anti-plagiarism package to be offered to the eligible universities who are the signatory to MoU with INFLIBNET Centre on Shodhganga. We hope that universities will have access to anti-plagiarism package under Shodhganga in the next academic year.

The process of e-content creation continued with greater zeal and fervor during this quarter. Workshops were organized for preparation of self-learning quadrant of e-content modules in the field of Library and Information Science and Food Technology. The workshops on both the subjects were held at the INFLIBNET Centre in the last quarter of this year.

Three programmes of "one-day" JSTOR User Forum were organized during October 2013 at INFLIBNET Centre, Gandhinagar, IIT Madras and TISS, Mumbai. Mr. John Lenahan, Associate Vice President, JSTOR came to represent JSTOR from US. Experts from Mumbai and Calicut were invited to deliver talks in the JSTOR Forum. All the three Forums were highly successful and there were demands from other universities to organize the Forum in their respective universities.

A User-Training Webinar on SpringerLink Platform was delivered under the N-LIST Project during December, 2013. The programme was attended by more than 455 users from 25 N-LIST member's colleges.

The Centre actively participated in the Diamond Jubilee Celebration of UGC. The Centre contributed to the organization of Diamond Jubilee of the UGC in preparation of video presentation on UGC as well as in the guest management.

The Centre celebrated Navratri with active participation of staff, their families and guests. Everyone participated in Garba dance during the celebration. An Article entitled "A Webometric Analysis of Institutional Repositories using Dspace in India" by Mrs. Roma Asnani is being published in this issue of Newsletter. The two repositories of the Centre namely, Shodhganga and Dspace @ INFLIBNET are also analyzed in the study for their impact as well as links to other repositories in India. I hope you will find the article interesting.



Research & Development Projects Recommended to Financial Support by the NME-ICT Standing Committee

Proposal on "Integrated e-Content Portal" by INFLIBNET Centre, Gandhinagar

The project entitled "Integrated e-Content Portal" submitted by the INFLIBNET Centre to NME-ICT proposes to host all e-content develop under the National Mission of Education through ICT onto one single portal. Currently, e-content projects developed under the Mission are distributed on the websites of respective Principal Investigators / their institutions in varied formats, types and size. There is no single interface, LMS or structured metadata available to search, browse and discover all e-content. The Centre will create metadata for all e-content projects developed under NME-ICT, MHRD, through which a user can draw maximum advantage from digital content that would also facilitate search and browse of all the content hosted on a single platform.

Major task under the project, would involve acquisition of e-content with all accompanied material in its generic formats from PIs of NME-ICT project, assign metadata to all e-content module, adapt and evolve a system with suitable backend database management system to host all e-content, links, inter-links and cross-links to other e-modules, develop multiple search interfaces to support search, browse and discovery of e-modules hosted on the platform, etc.

The project is being re-submitted to the standing committee of the NME-ICT with modifications proposed by the members of Standing Committee.

Proposal on Expert Database (VIDWAN)

The project entitled "VIDWAN: Expert Database" submitted to the NME-ICT proposes a database comprising of experts available in India in different disciplines as well as experts and academicians of Indian origin working abroad. The country has more than 700 degree awarding institutions, 35,000 colleges and more than 4,000 research institutions. It does not have reliable source of information for experts available and country in various disciplines of teaching and researcher. The database proposes to be a comprehensive source of information for experts wherein the database would be populated by invitation, nomination as well as through voluntary submission of research profiles by experts. The database will store the data in RDF/XML, network of coauthors and networks of subject disciplines would be created automatically using semantic platforms called VIVO. The proposed project would be a trusted source of information for scientists and researchers to network with each other, for researcher and students to seek guidance in their research area for funding agencies and policy makers to find expert for evaluation and assessment. The project has been recommended for funding by the Standing Committee.

N-LIST User-Training Webinar on SpringerLink Platform, INFLIIBNET Centre, 12th December, 2013

N-LIST User-Training Webinar on SpringerLink Platform was organized at INFLIBNET Centre using the A-View platform on 12th December 2013. Ms. Kruti Trivedi, Scientist B (LS), INFLIBNET Centre and Ms. Saba Quddus, representative of SpringerLink delivered

lectures during the webinar. 455 users from 25 NLIST members' colleges including principals, faculty members, librarian, research scholars and students attended the webinar.

Diamond Jubilee, University Grants Commission, New Delhi, 28th December, 2013

The University Grants Commission (UGC) completed 60 years of its existence with its mandate for 'coordination and determination of standards in universities' on 28th December, 1953, it has covered 60 milestones of its journey for qualitative improvement of higher education in the country. The Diamond Jubilee function was inaugurated by the Prime Minister Dr. Manmohan Singh; the function was presided over by the Minister for Human Resource Development, Dr. M.M. Pallam Raju. The Minister of State for Human Resource Development, Dr. Shashi Tharoor, graced the occasion, besides members of the Commission, Former Chairpersons of the UGC, Vice-Chancellors of Universities, and academics from all parts of the country.

In his inaugural address, the Prime Minister, while acknowledging the contributions of the UGC in the cause of higher education, suggested that "it should also now play the role of a national 'think-tank' and organize a professional and purposeful discourse about issues that have a bearing on the sound development of Higher Education in the county". He emphasized that in making interdisciplinary research and innovation the salient agenda of the university system, we can hope to improve our ranking amongst the top universities of the world.

He said that since 96% of students receiving higher education in the country are in the State higher education system, State universities, in particular, required attention and support to improve the quality of teaching and research. The Rashtriya Uchttar Shiksha Abhiyan will address this concern. He said that there is a need not only to continue the focus on the three Es of Expansion, Equity and Excellence but also add a fourth E of Employability.

The Prime Minister lauded the rapid expansion of higher education in the establishment of more Central Universities, IIMs, IITs, NITs, IISERs, IIITs and SPAs and also emphasized to make higher education more

inclusive. He referred to efforts to encourage skill development in a big way so that trained work-force is available to meet the needs of our growing economy and new opportunities for productive employment are created in large numbers. He referred to specific concerns like quality in shortage of faculty, strengthening university-industry-interface and research to address issues of critical national importance like climate change and disaster management, besides strengthening the university information management system on a priority basis for effective policy planning.

The Prime Minister expressed his happiness at the institution of five awards in the name of Pandit Jawaharlal Nehru, for individual excellence in the field of Science, Technology, Humanities and Social Sciences, Fine Arts and Culture.

The HRM, Dr. M.M. Pallam Raju said that issues and challenges in relation to access and expansion, equity and inclusion, quality and excellence will remain perpetual concerns in higher education and the UGC should focus on these challenges with increased vigour. He hoped that the national target to increase the Gross Enrolment Ratio to 30% will be achieved by the 2020, while referring to special schemes launched for nurturing social equity. He referred to autonomy of the higher education system and emphasized that academic, administrative and financial autonomy need to be addressed in an integrated perspective vis-à-vis accountability. He pointed to the need of evolving models of blended learning with online educational resources, as the requirement of future.

The HRM announced the creation of Chairs in the name of Nobel Laureates: Rabindranath Tagore, C.V. Raman, Hargobind Khorana, Mother Teresa, S. Chandrasekhar, Amartya Sen and V. Ramakrishnan in the university system. He felt that work done through these Chairs in our universities will become a perpetual source of inspiration for the younger generation of scholars.

Prof. Ved Prakash, Chairman, UGC said that the quantum of public funding for higher education has seen explosion in the volume of both students and institutions. He cited investment of about Rs.7,461 crore for the nurturance of social equity and excellence of higher education benefitting about 23 million students. He referred to the efforts of the UGC to nurture teaching and research environments in the universities through several initiatives and the support provided to the Inter-University Centres in the areas of Accelerator Based research facilities, Astronomy and Astrophysics, Consortium for Scientific Research, Educational Communication, Information and Library Network, Assessment and Accreditation and Teacher Education.


He highlighted some significant initiatives for prevention of caste-based discrimination /harassment/victimization and promotion of equality in higher education; establishment of mechanism for grievances redressal in the university system; mandatory assessment and accreditation of higher educational institutions; regulation and operation of foreign educational institutions in India.

Prof. Ved Prakash said that the phenomenon of the brain drain has been successfully reversed through the UGC's

faculty recharge programme under which 163 faculties who are Ph.Ds or Post-Docs from abroad have been appointed; the UGC takes care of their salaries but they serve different universities. Besides, some major initiatives namely: Singh-Obama 21st Century Knowledge Initiative, U.K. India Education and Research Initiative, India-Australia, India-New Zealand and India-Israel Education Councils, twinning arrangements between foreign and Indian institutions have been implemented.

He reiterated the reviewed commitment of the UGC for engagement with policy research, creation of authentic databases in higher education, enhancing technology mediated teaching and learning, strengthening mechanism of mandatory institutional and programme accreditation and structural and governance, reforms. UGC's proactive steps in regard to Anti-Ragging and measures of safety of women on the university campuses and gender sensitization will go a long way in ensuring a better learning environment.

A Webometric Analysis of Institutional Repositories using Dspace in India

Major technological changes have been noticed in scholarly communication and exchange in scientific communication since last few years. Web presence and appearance of scholarly content on the web has gained a special significance. This webometrics study is based on web impact factor of institutional repositories using Dspace in India with the help of OpenDOAR database for data collection, Google search engine and Pajek, network design software through WebCrawler Socscibot 4 for network analysis was used as a graphical tool for creating inlinks topology.

Introduction

Open access and high availability of scholarly content led to completely new area of research that deals with qualitative and quantitative measures of scholarly communication and publication. Open access journals and institutional repositories are two important component of open access publishing system. While open access journals publish scholarly content following traditional tools of peer review and make them available free of cost for the user, institutional repositories host digital documents of an institution that are organized, preserved, and made accessible to worldwide user community. Lynch (2004) has pointed out that an institutional repository needs to be a service with continuity behind it ... Institutions need to recognize that they are making commitments for the long term". The main aim of creating and maintaining IR is to bring like "hidden shells which contain pearls" to the users from inside as well as outside the institutions who are in search of related scholarly contents. Researchers can access these scholarly contents across the world through open access system over Internet.

The science of webometrics (also called cybermetrics) deals with measuring the World Wide Web to analyse number and types of hyperlinks, structure of the World Wide Web and usage patterns. Björneborn and Ingwersen (2004), defines webometrics as "the study of

the quantitative aspects of the construction and use of information resources, structures and technologies on the Web drawing on bibliometric and informetric approaches." The term webometric was first coined by Almind and Ingwersen (1997).

One relatively straightforward measure is the "Web Impact Factor" (WIF) first introduced by Ingwersen (1998). According to Alastair G Smith (2013), web impact analyses are based on counting and analysing the URLs returned by search engines in response to queries designed to match documents or ideas with a purpose to produce indicators of the extent to which the documents or ideas are mentioned online, either to directly access web impact or to indirectly assess predominantly offline impact through measurement of the online component of that impact.

Literature Review

Webometric studies is based on the use of large-scale search engines, such as Google, Yahoo, Altavista, Exalead, Blekko and Bing that allow measurements to be made of the total number of pages in a web site and the total number of backlinks to the web site.

Ingwersen (1998), analysed WIF of seven small and medium scale national and four large web domains as well as six institutional web sites. He stated that data

isolation method makes use of sets of inverted but logically identical Boolean set operations and their mean values in order to generate the impact factors associated with internal- (self-) link web pages and external-link web pages.

Alireza Noruzi (2006), stated that Web Impact Factors can be calculated as a way of comparing the attractiveness of web sites or domains on the Web and concluded that while the WIF is arguably useful for quantitative intra-country comparison, application beyond this (i.e., to inter-country assessment) has little value.

Amit Kumar Das (2008) examined 28 institutional digital repositories listed in OpenDoar using altavista search engine and measured the visibility of the website and ranked them through web impact factor external links.

Aguillo (et al.) (2010) pointed out that webometrics indicators can be categorised into three groups namely activity related (documents deposited by author, institution, subject), usage related (visits, visitors, downloads), and visibility related (citations and web links) with the help of search engines. He also shown snapshot of top 300 repositories from a total of 592 worldwide, with a strong presence of US, German and British institutional repositories and the leadership of the large subject repositories through Ranking Web of World Repositories website.

Alastair G Smith (2013) explored webometric measures that could be used to evaluate the impact of institutional

repositories, using institutional repositories at tertiary institutions in Australia as a case study. URL citation inlinks (occurrences of the repositories' URL in the text of web pages), as found through Google searches, as well as links from the general web, links made from other Australasian academic institutions and from Wikipedia.

Objectives

The objectives of this study are as follows:

- To find out visibility and the performance of Indian Institutional Repositories using Dspace;
- To know the relationships between the number of web pages, inlinks and selflinks; and
- ·To calculate the web impact factor.

Data Collection

This webometric study is based upon link counts of Indian IRs using Dspace. The data required for analysis was collected from OpenDOAR. OpenDOAR contains data for 67 IRs across the country including 42 IRs that are using Dspace. Google search engine was chosen for getting results from 31 IRs that are active working properly, remaining 11 institutional repositories that are not working properly, were left out of this study. The results required for WIF calculations were obtained from the google search engines using advance queries. Search results were collected for each IR keeping various search conditions constant for each IR within a single day (23-12-2013). The methodology followed can be stated into the following four steps:

Methodology

Web Impact Factor (WIF) is the web versions of impact factor. The WIF provides quantitative tools for ranking, evaluating, categorizing, and comparing web sites. There are three types of link. External links (inlinks or backlinks) i.e. links coming into a site from other sites, self-links i.e. links within the same site and total links i.e. total number of links to a site. There are three types of WIF: External link WIF, self-link WIF and total WIF.

Let,

A = Total number of web pages to a particular site

B = Number of external links (inlinks or backlinks) to a given site

C = Number of self-links to a given site

D = Total number of links to a site

Therefore, WIF external link = B/A, and WIF self-link = C/A, WIF simple (total links) = D/A;

Result

The Web Impact Factor for institutional repositories using Dspace in India is given below:



The WIF analysis evaluated the visibility and impact of institutional and academic web sites, as well as their competitive relations to other web sites. WIF External link measured the visibility of the website and could be ranked them through web impact factor external links. In the above table, Institutional Repositories of Indian Institute of Management Kozhikode, Thapar University and INFLIBNET Centre (Shodhganga) have good WIF external link for web visibility as compared to other repositories. National Institute of Oceanography has highest numbers of webpages, inlinks, selflinks and total links pages. The WIF provides a way to evaluate a web site's relative importance, especially when we compare it to others in the same field, Shodhganga: A reservoir of Indian Theses, Digital repository of Cochin University of Science & Technology (Dyuthi) and Indian Institute of Science, Bangalore (edt@IISc) are electronic theses and dissertation repositories. Shodhganga has highest

number of webpages, inlinks, selflinks and total links pages and web impact factor also highest as compared to other electronic theses and dissertation repositories.

Link mapping of Institutional Repositories

Pajek, Software available on SocSciBot (http://socscibot.wlv.ac.uk/) was used for generating inlink topology for 31 institutional repositories covered in the study. The network diagram showing links between 31 IRs covered in this study is given below. The link analysis point out that 3 repositories namely, Shodhganga, Dyuthi and edt@IISc are related to each other on similarity index. It may be noted all the 3 repositories host electronics version of theses and dissertation.



Conclusion:

Ease of access to web sites, site language, site updating and type of materials has all been identified as contributors to the WIF. In the WIF analysis, a good authority is a well-linked, popular page on a topic. The WIFs are always approximate and not absolute. The web pages, inlinks, selflinks, total links and web impact factors are not stable, because everyday webmasters may delete the old outlinks to several websites and others are linking to new ones. Noruzi (2006), stated that a website's ultimate success depends upon its quality and other competitive factors including its size, language, visibility, feasibility and popularity and not only its impact factor. Link analysis using suitable software can be used effectively to identify repositories that are hosting documents of similar nature.




